Murfin No. 22 spud the subject well 11-5-85 with a 12 1/4" bit and drilled to a TD of 700'. Ran 9 5/8" 32.3 # casing and set at 700'. Cemented with 450 SX class H cement and circulated 116 SX to pit. WOC. Pressure tested casing 1200 psi for 30 mins - ok. Reduced bit to 8 3/4" and resumed drilling to TD of 2492'. Ran 7" 20 # casing and set at 2492'. Cemented with 800 SX class H cement and circulated 387 SX to pit. Rig released 4:30 am, 11-10-85. No further report until MICU.
