Aztec Rig #56 moved on and spud well 11-19-84 with a 12 1/4" bit. Drilled to TD of 820' and on 11/20/85 set 9 5/8" 32.3 #, H-40 csg. Csg set at 717'. Cemented with 390 sxs. Plugged down and circulated 53 sxs to pit. WOC and tested csg to 1500 psi for 30 min, OK. Reduced bit to 8 3/4" and drilled to TD of 2662'. On 11-25-85 ran 7", 20 #, K-55 csg. Csg set at 2656'. Cemented with 650 sxs class H w/add. Bumped plug and circulated 235 sxs. Rig released 11-25-85. No further report until MISH.
