Aztec Rig No. 56 spud the subject well with a 12 1/4" bit, on 10-15-85. Drilled to a total depth of 711'. Ran 9 5/8" 32.3# casing and set at 706', on 10-16-85. Cemented casing with 390SX with additives. Circulated 105X to pit. WOC. Pressure tested casing to 1600 psi for 30 mins - ok. Reduced bit to 8 3/4" and resumed drilling. Drilled to a total depth of 2202'. On 10-19-85, ran 7" 20# casing and set at 2,201'. Cemented with 550SX Class H with additives. Circulated 150SX to pit. Rig released 9:45am, 10-19-85. No further report until MICU.
