Service Rig No. 6 spud the subject well 10-27-85 with a 12 1/4" bit. Drilled to a TD of 706'. On 10-28-85, ran 9 7/8" casing and set at 706'. Cemented with 450SX class H cement. Circulated 1595X to pit. WOC. Pressure tested casing 1200 psi for 30 mins -ok. Reduced bit to 8 3/4" and resumed drilling. Drilled to a TD of 2425'. On 11-2-85, ran 7" casing and set at 2425'. Cemented with 650SX class H with additives. Circulated 1825X to pit. Rig released 11:45 am, 11-2-85. No further report until MICU.
