Murfin Rig #22 moved on and spud well 11-22-85 with a 12 1/4" bit. Drilled to TD of 695' and on 11-22-85 ran 9 5/8", 32.3", H-40, csg. Csg set at 693'. Cemented with 425 sxs class H' w/additives. Bumped plug and circulated 50 sxs to pit. WOC, tested csg to 1200 psi for 30 min, tested OK. Reduced bit to 8 3/4" and drilled to TD of 2419'. On 11-26-85 ran 7", 20", K-55 csg. Csg set at 2419' and cemented with 800 sxs class H' w/add. Bumped plug and circulated 380 sxs. Rig released 11-26-85. No further report until MISHU.
