Max TP 2480, Avg TP 1750, Air 20.0 BPM. Showed well to clean up. well started to make lots of sand. Ran tubing and bit and drilled cement from 2216' to 2224'. Circulated well clean. Pulled tubing and bit. Show tested well and hooked up to sales.
