Move in rig up rotary tools. Drilling 12-1/4" hole. Run 17 jt. 8-5/8" 23# casing. Set @ 739'. Cement with 285 sacks Prem. Plus 2% cc 1/4# Flocele. Circulate 63 sacks to pit. Wait on cement. Test 8-5/8 to 500 psi. Held OK. Drilling 7-7/8" hole 739' - 2340'. Run 57 jt. 5.5" 14# casing. Set @ 2330'. Cement with 60 sacks Prem. Plus @ 11.1 and 75 sacks Prem. Plus @ 13.2. Both 3% cc 1/4# Flocele. Circulate 24 sacks to pit. Plug down @ 4:45 on 5-26-98. Rig down move out rotary tools. Wait on completion unit.
