DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Per approval of C-101 drilling was begun Aug. 1st. 1951 and continued to a depth of 100 Ft. where surface water was encountered. This was a small flow and drilling was continued to 130 ft. at this point a hard rock was penetrated that tended to crook the well and at 150 ft. well was filled back to 130 ft. with rock and an attempt to straighten well was made. After two attempt with rock filling failed powder was used to straighten well.

After straightening drilling was continued to 200 ft. and 10" casin. is now being set to seal off surface water as no more water has been encountered.

Notice of above was submitted on form C-101 and approved by your Office.

No change in original plans have been made.
