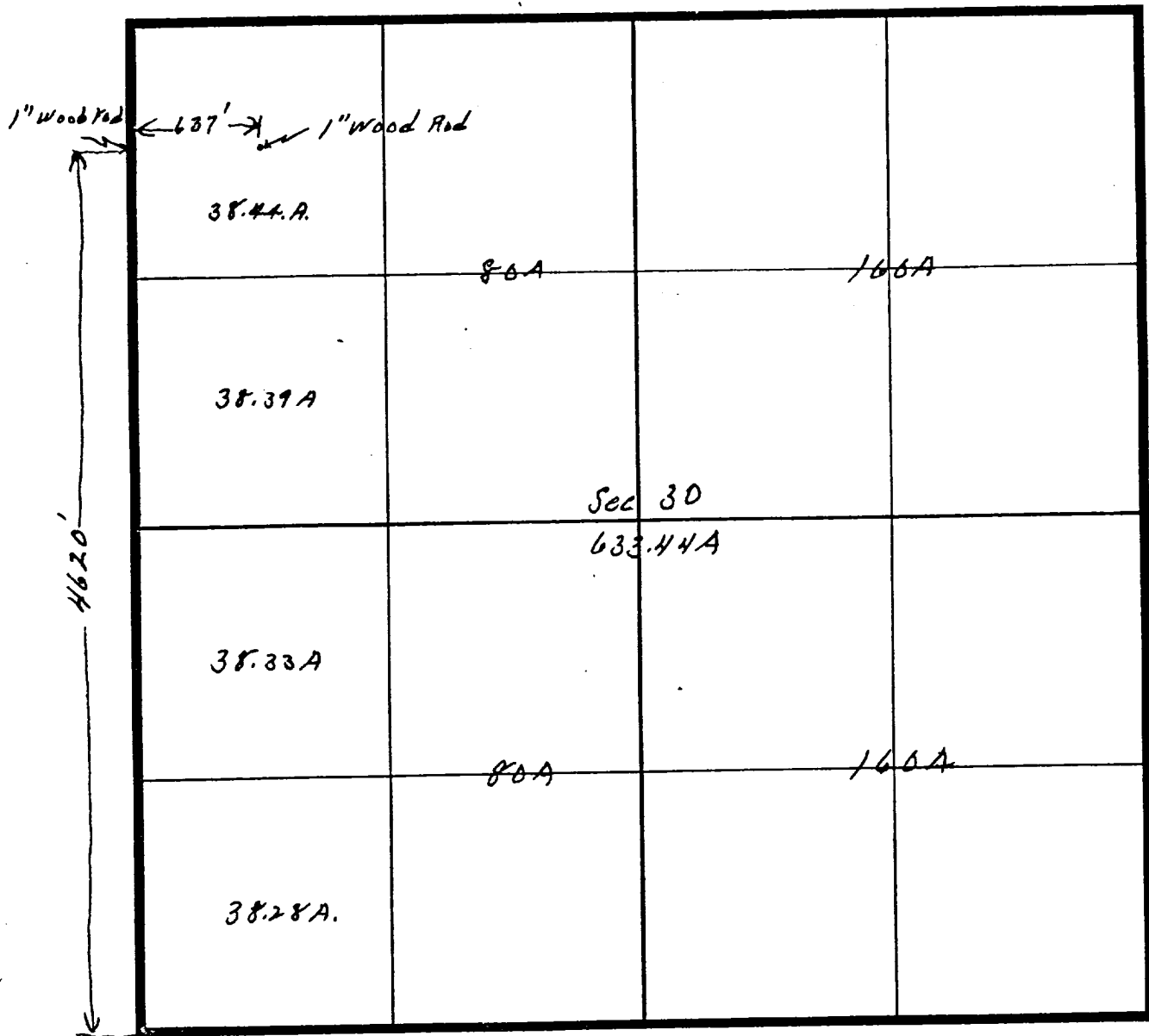

I, Manson Edmondson, State that I am the registered Professional Engineer and Land Surveyor, who made the attached plat, which shows the location of the center of the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 30 Township No. 20 North of Range No. 36 East of the N.M.P.M., and said plat was prepared from field notes of actual survey made by me and under my supervision, and that the feet and acerages were surveyed to conform to the survey made by Fuss and Holland, March 1881, and that said mean declination was found to be approximately the same as shown by the map prepared by them in 1881, and that this survey is true and correct to the best of my knowledge and belief.
