On the above date A cement sealing plug was set in this well. The cement was pumped in under pump pressure from 450' back to 390'. 25 sacks of Portland quick set cement was used and the plugging operation was witnessed by A B Hughes JR. (property owner)

On 9/15/61 389' of 5 1/2 inch casing was run in this well and cemented with 22 sacks of Portland quick set cement. The casing was set on top of the sealing plug. The hole below the sealing plug was full of 1 1/2 lb. drilling mud.

Operations are temporarily suspended untill a determination is made on whether to test a slight logged show or to transfer the well to MR Hughes for conversion to a water well.

The commission will be informed of the decision.
