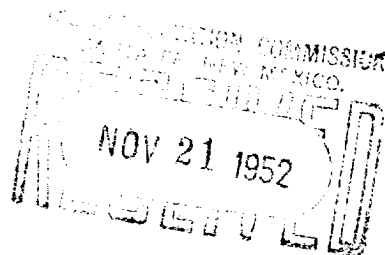

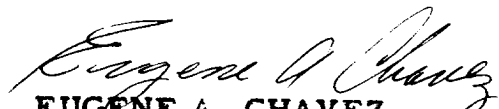
Dear Sir:

Please find enclosed your approved copy of Form C-103, report on abandonment for conversion to water well covering the Hopson well as above captioned. Also find enclosed your approved copy of forms C-102 and C-103, Notice of Intention to Convert to Water Well and report on conversion to water well concerning the Wallis well as above captioned.

In checking our files I note that we have no record of the R. L. Nunn - #2 Richards well as having been spudded. In order to release Mr. Nunn's blanket bond the work on all wells either drilled or locations approved for drilling covered by said bond must be properly terminated as specified in the Oil Conservation Commission's Rules and Regulations.

I intend to be in your vicinity the early part of next week at which time I shall call upon you to assist me in a final check on these wells and locations. 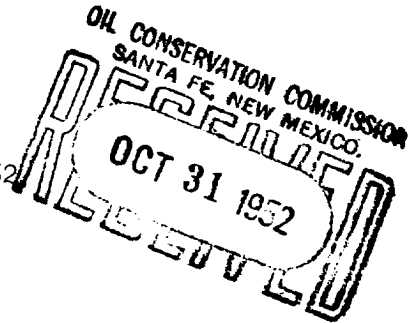

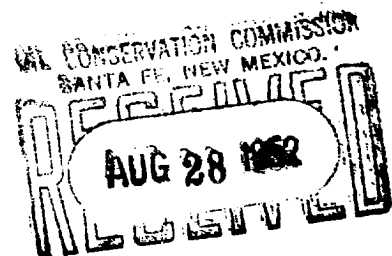

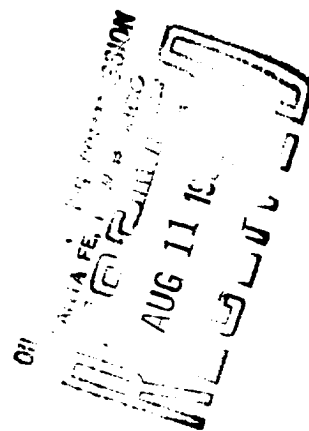

I have your letter of August 5th, enclosing the blanks for use in making the applications to plug the wells.

I sent you a copy of the log on the Wallis well, and as you will note, there is 245 ft. of 10" casing and 611 ft. of 7", and it is cemented in with 150 sacks of cement, and there is very little chance of being able to pull any of it.

If we plug the well very far, we would shut off the water which was encountered at 611 to 622 feet. This water has not been tested as to volume, but it is possible it would produce enough water to irrigate a small tract of land, which would be worth a good deal to the land owner.

Since this well is only 748 feet deep, and the land owner wants to use it for a water well, and Mr. Nunn does not intend to try to salvage any of the casing, it seems to me it would be practical to simply leave it as it is, and let the land owner use it in any manner he wishes, either just for stock watering purposes, or for irrigation.

Please let me know whether or not you would approve this?

Dear Sir:

I wish to acknowledge receipt of your letter of the 8th and regret not answering sooner due to my absence from the Santa Fe office most of last week. I have also received your log and accompanying note of August 5th.

After reviewing the log, I am in complete accord with your proposal and manner of converting to a water well. It is understandable now that a bottom plug is impractical and unnecessary. We assume that none of the 245' of 10" and 611' of 7" casing strings will be pulled or tampered.

I am enclosing in triplicate, Oil Conservation Commission forms 102 filled out and detailed as to your intentions. The land owner's signature on form C-103 assuming full responsibility for the well as converted will release your client, Mr. Nunn.

A log of the Jim Hopson No. 1 well is still pending.
