DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well drilled to a depth of 969 feet; 294 feet of 10" casing in well; 577'-9" of 8" was set, but about 371 feet of it later pulled, and the remainder was accidentally dropped back in the hole. I am willing to accept the hole as it now stands, relieving the Richard L. Munn Company of further responsibility as to plugging, for the reason that I want to use the well for irrigation purposes if on test it develops that it will furnish sufficient water, and if not, use it for stock watering purposes.
