FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Spudded this well Monday Sept. 17th. 1951. Hit sandy formation at about 25 ft. and got the hole down to 200 ft, and sand falling in so bad stopped drilling and have ordered out a string of 10" casing to run, no water as yet.

The plan is to run this casing down to the 200 ft, then under-ream or drill with a reaming bit and take the casing down a joint at a time until we hit water or a good hard formation to set the casing on, which might be in a few feet or it might be several feet yet through this sand formation.
