550- 50 Heavy Mud
50- to top of 10-3/4" casing in collar 25 sx cement
Steel cap and 1' cement slab on top 10-3/4" surface casing
Fill cellar and place 4 1/2" steel marker extending 4' above exact hole location.

We have filled out your Form #105 - Well Record - as far as our information is available, and have forwarded these forms to our Tulsa Office to be completed.

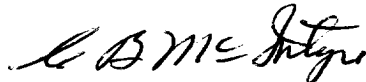
The well, for which this information is needed for your form, is our N. M. Van Pelt well No. 1, located in Section 9-28N-35E, Union County, New Mexico.
