

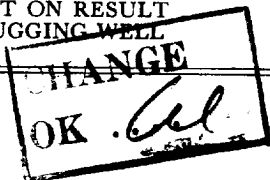

Spudded in the above well Sept 27th, 1954 with Walker-Neer. Cable tools. Started with 12 1/2" bit, app 15" hole. Drilled three days to a depth of 142 feet, closed since awaiting return of drillers not expected to resume work until first of next week, 11th Oct, 1954. Presently making necessary adjustments and improvements necessary for winter operation. Sufficient water for drilling operations at 108 ft, continue strong in sand and shale.
