DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This well was drilled to a total depth of 3514'. Former plug back reports show that there is now heavy rotary mud in the well from 3514' back to 3100', solid cement from 3100' back to 2611'. The 5 1/2" casing was originally set at 2636', then in plugging back, cement was left inside the 5 1/2" casing up to 2611'. The 5 1/2" casing was knocked off at 1836' and pulled, leaving the balance in the hole. We then cemented with 60 sk. of cement from 1836' to 1548' (2-5/8" Csg set at 1516' & cemented to surface). Cement lot set 10 hours, then tested & found OK. The 2-5/8" casing was then filled to surface with heavy rotary mud, then steel capped to complete the plugging of the well. Steel well marker will be installed when the rig has been moved.
