Well spudded 3-23-71. Drilled to 112'. Ran 5 jts (118.46') of 8-5/8" casing, set at 106.54' with 150 sacks Class A with 2% calcium chloride. Circulated 20 sacks. Plug down @ 2:00 A.M. 4-24-71. After 24 hours, tested with 1500# for 30 minutes. No pressure drop.

Drilled to 3028'. Ran electric logs 4-10-71.

Ran 91 jts (2967.05') of 5-1/2" J-55 14# casing, set at 2975.55' with 300 sacks of Posmix. Plug on bottom at 5:45 p.m. 4-11-71.

Waiting on completion rig.
