Spudded 12 $\frac{1}{4}$ " hole on 12-28-85 and drilled to 372'. Set 8 5/8" @ 336'. Cemented with 105 Sxs of Class A w/2% CaCl₂, POB @ 1 AM, 12-30-85. Cement did not circulate. Pumped 6 $\frac{1}{2}$ yds of redimix down annulus. Cement circulated.

Drilled out cement and drilled to 407' with 7 7/8" hole.
Communication with Penteco-Trinity #1. Moved off drilling rig.
