DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On April 27 / 1947 an electric log was taken by Halliburtons which showed up good from 625 to 655 then again at extreme bottom. Set 4 " pipe at 795 Ft. and cemented with 50 sacks of cement pumped back of pipe by Halliburtons cementing service, then tested bottom pay for oil but had failed to get all water cemented off so due to small size of hole gave up further efforts to make producer there at that level so cemented bottom solid up 40 Ft. in pipe and made one small perfection at 634 Ft. which brought in small amount of sweet gas.
