DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Before drilling out cement plug we tested the casing on Feb. 8, 1944, with 800 lbs. pressure and found it O.K. We then drilled out cement plug on Feb. 9th and then bailed down to 1900 feet. Allowed well to stand idle for 12 hours and tested and found fluid had risen 1,000 feet. We are now drilling ahead.
