Lupe,

I am going to go ahead and approve this closure report because it is in a pad area. I probably wouldn't approve a no-excavation with these contamination levels, even at this depth to groundwater, if this had gone off the pad.

This closure request is approved as written. BLM approval does not relieve the operator of liability, should their operations fail to adequately investigate and remediate contamination that may pose a threat to groundwater, surface water, any other aspects of the natural environment, human health, or if the location does not properly reclaim. In such an event that location does not re-vegetate, or future issues with contaminants are encountered, the operator will be asked to address the location until contaminant issues are fully mitigated and the location is successfully reclaimed. In addition, BLM approval does not relieve the operator of responsibility for compliance with any other federal, state, or local laws/regulations.
