Amanda,

Due to the age of the analytical data, and the massive amount of rain this area received since the sampling event, the OCD would like to see this area resampled for chlorides before proceeding with this work plan. It is quite possible that the chlorides in this area have been driven further down, or even diluted to the point that surface disturbance is not necessary. The OCD would also like to see another sample point added about 50 feet east of sample points 3 and 4, to capture data in what appears to be the runoff path from the rains.
