Your proposal for closure of the above referenced release is accepted by NMOCD. Please note that the site was given a site ranking (per NMOCD Guidelines) of zero (0). Current OSE data indicates ground water has been encountered at less than 100'. A water well drilled in the same unit letter as the 11/8/14 release shows depth to ground water at 55' bgs. This well was drilled in February 2015, so OCD understands this data would not have been available at the commencement of this project. Given the depth to ground water, the revised site ranking is 10, which changes the RRAL for TPH to 1000 mg/kg. This level was met in all areas of the excavation with the exception of sample point RP RE, which returned a value of 1,144 mg/kg TPH at the 9' interval. The closure report indicates this area was excavated to approximately 10' bgs, but not sampled below the 9' interval. Also, the E-Wall RE returned a value of 1,163 mg/kg TPH at 6' and was not sampled beyond that interval.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment.
