Ms. Griffin,

The OCD is in receipt of your work plan for the above listed site. Unfortunately, we cannot approve this work plan as it stands. We must first see a complete vertical delineation, with a chloride delineation goal of 250 mg/kg (or background.) In addition, we would like to request surface samples in the ½ acre overspray area.

According to OCD maps, this release is in unit letter A of section 25, not unit letter D. The Trend Map puts this site in less than 100 feet to ground water.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
