We had Diversified take a composite sample of the areas of SP-2 & SP-3, and ran the PID. The reading that we got back was 69.4, which is below the acceptable level (100). We have removed approximately 2' in the areas of SP-2, SP-3, and some of SP-5. The liner is in the process of being installed, and the pad will be rebuilt. The area is to be expanded to approximately 150' x75' south of where the berms divided the tanks and the heater treaters. The areas of SP-1, SP-5, & SP-6 will be addressed once the location has been put back into service. After the location has been put back into service, we can meet on location to discuss the best way to proceed with the remaining areas to be remediated.
