Hi Mike,

Per our discussion on Friday, the NMOCD has approved excavation of the Skelly B Tank Battery leak. Considering the depth to groundwater, a liner will be installed in a portion of the excavation. The areas of SP1, SP2, and SP3 will be excavated to 1' bgs. The areas of SP4 and SP5 will be excavated to 4' bgs and a 20 mil reinforced liner will be installed at that depth. A 1' lift of sand will be backfilled above the liner for padding. The remaining 3' will be backfilled with caliche. The NMOCD stipulates that the pump in the area of SP5 (source of the leak) will either be reinstalled above said liner after backfilling and bermed or the pump will be moved to another bermed section of the battery. Please contact me if you have any questions and/or concerns regarding coming activities.
