

The impacted area on the pad was mechanically excavated to an average depth of 6" below grade. The impacted soil was stockpiled and then transported to division approved disposal facility. Fresh caliche was brought in for reconstruction of the impacted area. The caliche was spread and leveled bringing the pad back to grade and then rolled for compaction.

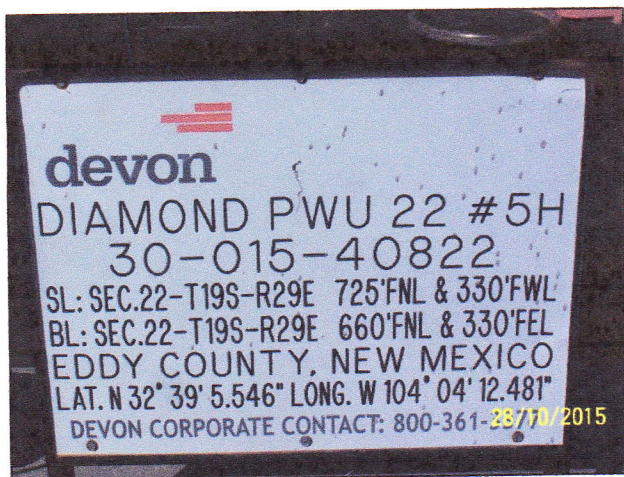
