

Your proposal for remediation of the above referenced release is approved with the following conditions of approval:

Available data indicates that ground water may be encountered at less than 100' bgs in this area, giving a site ranking of 10. Remedial goal for TPH will be 1000 mg/kg. In the area identified as SP-6, OCD will require a deeper excavation than proposed, with confirmation samples to insure the RRAL for this site is met.
