This report address the remediation at Devon Energy Production Company's Ross Ranch 10 Fed #1 located in rural Eddy County, New Mexico. The release was the result of fitting failure inside a lined facility. A pin hole in the liner allowed a small amount of produced water to escape the containment.



Remediation Activity Summary

The remediation was conducted according to the NM OCD and BLM approved work plan. An impacted area of 15' x 20' was excavated to a depth of three feet BGS. The excavation was then lined with a 20 mil synthetic liner and backfilled with fresh soil. The area was brought to grade and contoured to match the surrounding terrain.

Vernon,

I do not believe that 2RP-3427 is the correct incident report for this release. 2RP-3427 is around the pump and is already being addressed by a different environmental contractor. I believe the correct incident is 2RP-2342. This release resulted from a leak in the liner and affected the south side of the pad. I have attached the Initial C-141 for 2RP-2342 for your reference. Please consult with Devon to see if you concur.

That said, your proposal to clean the affected area is approved. Like approval by BLM is required.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
