Your proposal for remediation of the above referenced release is approved. It is OCD's understanding that 1' of material has been removed, and the proposal is to remove an additional 3' (4' total removal). A 20 mil liner will then be installed. OCD would prefer to have the area identified as S4, excavated through the 6' interval to remove the 9000mg/kg numbers. If Yates elects to remove this additional material, the area could be backfilled to the 4' interval with caliche and then the liner installed across the entire excavation. Please advise once remedial activities have been scheduled. Federal sites will require like approval from BLM.
