Your proposal for remediation of the above referenced release is approved. Please advise if the proposed excavation depths are not achieved. It is OCD's understanding that after the proposed soil removal, impacted material that remains on the well site, will be deferred to a later date or, site abandonment. Upon receipt of closure documentation, entries will be made in OCD data base referencing the deferment, and the incident will remain open in the database.

Federal sites will require like approval from BLM.
