We can approve the use of Aspen Grow in this area, but we will first need an upfront delineation and a site map. Also, this was reported as a 200 bbl spill, but your report calls it a 2000 bbl spill. I believe the original reporting is the correct amount. I would recommend revising your work plan to avoid any confusion.
