In addition to that, the proposed amount of soils to be removed/remediated will be excavated in 14 days. For this location, I was mostly waiting on feedback from NMOCD and in the future will probably request to have contaminated soils picked up within 30 days if no work plan is in place and/ or remediation not completed within 45 days.

After further review of the above referenced release site, and the proposed soil washing procedure for remediation of the impacted material, OCD does <u>not</u> approve the soil washing method in this instance. Given the potential for encountering ground water at less than 50', the site is also situated in a BLM mapped "High Karst Potential" area. OCD would encourage submittal of a similar proposal for a release occurrence at a more suitable location for this method of remediation. At this time, please submit an alternative remediation method for this release.
