Henryetta,

With regard to the aforementioned agreement, we have completed the application on behalf of J. Cleo as best we can without further explanation. When calculating the fee associated with the "reclamation and spill removal" area, we determined through geo-referencing the impact area (0.13 acres) and the access road (0.04 acres) over GoogleEarth that a total of 0.17 acres will be disturbed during remedial efforts. The fee per acre according to the BLM schedule is \$99/acre. Is there a whole acre increment requirement or does J. Cleo pay the calculated amount of contribution totaling \$16.83 toward the PB Cultural Resource Mitigation Fund? Please help us understand the BLM's requirement for such fees.

In addition, a revised C-141 will be issued to the NMOCD with the closest well API listed as the release source as suggested. We have reached out to Mike Bratcher, NMOCD, to determine if the OCD has groundwater depth information available for this area. This information will be input into the OCD's Site Ranking Criteria Form to determine required clean-up concentrations. We performed an independent groundwater depth search on the NM Office of the State Engineer's website and found the closest well to be 4 miles from the center point of the release area. Once we receive feedback from the OCD, we will send both the BLM and the OCD a recommendation for clean-up of residual site contamination.
