## Crystal,

Initial soil sampling that ETC Field Services, LLC (ETC) performed after the release indicates that the area was affected primarily from a spray that landed outside of the fence and in the pasture (see the attached release diagram). They separated the release into three areas – heavy soak, medium soak, and light overspray. Depth to groundwater is estimated to be between 110 and 128 feet based on USGS data (see attached).

ETC collected a sample in each area at about 1 foot below ground surface in each area. The analytical data (see attached) indicates TPH, BTEX, and chloride concentrations below the RRALs. However, ETC would like to scrape up the impacted soil in the most heavily sprayed area before it rains or they get any moisture. Following the excavation, additional soil samples will be collected to document any remaining concentrations. Would this be acceptable?

Dean,

It appears that the submission of your initial C-141 for this release was submitted to District 1. Olivia forwarded the form on to us. I see that you mention that you have verbal approval from SLO to commence work, not sure what all you are out there doing currently. OCD is commonly receptive to operators taking immediate response action often without written approval from OCD to do so. However, since it is not clear what kind of work ETC will be commencing OCD will say this, all production fluid releases are to be properly delineated and remediated to OCD standards. This is a reportable release so laboratory sampling will need to be provided to OCD and will require that it be based on OCD rules, regs and COA expectations.
