Thank you for the submission of the site characterization. However, the site map is lacking sampling points S2 and S3 being marked anywhere on the map. Since I am unaware of where the sample points I just mentioned are located in accordance with the spill plume I will say this, we definitely need to see lab data from a sample point as close to the point of release as possible which I see in your write up you say WPX is working on getting results for samples close to the point of release. Good. Also for the amount of area that this spill has traveled more delineation sample points than 3 will be required in order to properly define this spill plume. Please make sure to refer to the directions of the COA when conducting the delineation. No approval of a site characterization plan can be provided until the full delineation is achieved and all the lab data is presented.
