Please find the attached C-141 for your consideration. Also, attached is the calculation sheet to determine the estimated release volume. The liquid lost estimate is based on the spill dimensions and estimated depth of fluid (wet gravel depth). The spreadsheet will calculate the volume lost in the gravel, but does not include the recovered amount in the calculation.
