Depth to GW is can be difficult to accurately define. The well used to assess depth was the closest well with information, at 250 below ground. The others in the vicinity indicate water is much shallower, ~50-100 feet. It seems there is something off about that well. At any rate the site was remediated in accordance with the spill rule, however reclamation has yet to occur. Once the site is backfilled with unimpacted soil and revegetated NMSLO will issue closure to 2RP-5250. NMOCD may have additional questions or concerns.
