Jacqui,

I'm not sure why our DTW measurements from our Environmental Map are so different from the ones that you pulled off of the State Engineer's website? Our Environmental Map shows no wells in close proximity to the Wolfman 5/4 WOLI Fed Com #1H in Unit L, Section 5, Township 23S, Range 27E that have a DTW over 100'. The closest well is 82.7', which is a few hundred feet slightly south east. Anyway, the DTW at this location is over 50 feet and the entire release area was excavated to the depth of 4 feet bgs. With the elevated amount of chlorides left in place, the OCD suggests that a liner be put in place to prevent further deposition of Chlorides at this location.

We have received your closure report and final C-141 for **2RP-5250 Wolfman 5/4 WOLI Fed Com #1H**, thank you. This closure is approved.
