**2RP-4913**

Spill date – 7-25-2019  
1 bbl was released through small hole in containment and liner was patched  
RP number is located on the compliance agreement and will be remediated by a third party contractor

**2RP-4808**

Spill date – 7-26-2019  
Everything remained inside containment

**2RP-4911**

Spill date – 7-27-2019  
Everything remained inside containment

The 24 hour notifications, signed C141s, and photographs from the inspection of the frac tank containment are attached. The pictures were taken after the releases occurred, fluid was recovered, and liner was inspected. The C141s were signed by Maria Pruett.
