We have received your Workplan/Remediation Proposal for <u>2RP-5380</u> Saragossa 10 St #2, thank you. This Workplan/Remediation proposal is conditionally approved. All samples appear clean at a depth of 2 feet. Pad Area Polygon #1 was proposed to be excavated to a depth of 6", Pad Area Polygon #2 to a depth of 10", and Polygon #3 to a depth of 4". Republic Backhoe might need to excavate deeper than these proposed depths. The samples clean up somewhere between surface and 2 feet on all samples. Not sure if its 4 inches or 24 inches? The site will need to be remediated to the <50 ft closure guidelines and all closure samples should meet the OCD <50 ft soil sample limits.
