Hello Mr. Boyle,

OCD has received your closure request for 2RP-4894, thank you! Please fill in the Closure C-141 on the updated form so I can continue to process this closure. In addition please address the following:

1. Why are the lab reports preliminary? Also, the lab report documents a discrepancy between labeling.
2. The top 4' in the pasture should be non-detect or background for all 4 contaminants in Table 1. This will affect SP5 and some side wall samples.
3. For future releases per OCD Santa Fe, delineation samples should test for all 4 constituents at all levels, only final samples may not test for samples previously at non-detect.
