Hello Maria,

We received the run ticket from the vacuum truck company the client utilized for spill cleanup (attached) which shows the 480 bbl recovery associated with the produced water release. Upon reviewing the run ticket, we noticed that the date of the recovery was listed as October 31, 2018. Longfellow Energy informed Sport Environmental that the release occurred overnight on October 30, 2018 and was quickly recovered upon discovery on October 31<sup>st</sup>. Our contact at Longfellow (David Cain) also received this more accurate information on the release date today.

Attached please find a revised C-141 that has been updated to reflect the October 30, 2018 release date.

Thank you for your message. The secondary containment area was not lined.

The release volume was estimated by the client based on the recovery volume and minimal seepage to the soil on account of the rapid initial recovery efforts which took place. Run tickets from the pump truck that was utilized during the recovery work have been requested and we aim to have that information to NMOCD as soon as possible.

Mr. Griswold, Mr. Bratcher, and Ms. Pruett:

Sport Environmental Services, LLC (*Sport*) has been retained by Longfellow Energy, LP (*Longfellow*) to assist with C-141 submittal, remediation and reporting associated with the State 20B release. The release occurred on November 4, 2018 and was caused by a lightning strike which in turn caused pump failure and resulted in a tank release. The released produced water was fully contained within secondary containment and all free fluids were recovered immediately following release discovery. Attached please find the **initial, signed Form C-141** associated with this release. Longfellow personnel reported the release to NMOCD District 2 at the time of discovery.

In addition, please find a **Form C-141 Supplement** which outlines additional assessment work performed inclusive of release impact mapping, geo-tagged site photographs, and groundwater depth determination documentation.

Once initial analytical results are received, a remediation work plan will be submitted to the NMOCD for approval. Advanced notification of field activities and official sampling events will be provided at least 72 hours in advance.
