XTO is requesting an extension to the 90-day timeline for completed remediation and closure report submittal required in 19.15.29.12.B.(1) NMAC at the Poker Lake Unit 23 DTD 108H (RP# 2RP-5287). The release was discovered on February 13, 2019. Drilling, completion and flow back activities on and around the site, as well as equipment located at the site have prevented XTO from completing preliminary sampling and remediation activities. The 90-day deadline from the release date is May 14, 2019. XTO request an extension of this deadline until September 14, 2019.
