Per our conversation earlier today, I can confirm that the area around sample SW4, near the canal, was hand excavated, and then the sample was collected. The SMA staff's timesheet entry indicates on August 28, 2019 "on location guiding excavation of material against irrigation ditch by hand..." Prior dates to that entry are notes indicating coordination with the landowner for this work.
