I have attached the three SDSs for the frac fluid mixture used on this location. After reviewing these ourselves and consulting with a local lab, we have come up with a proposed sampling list. We will be collecting soil samples today and will analyze for the following with your approval:

Scaleblok – no listed chemicals.

Microbiocide – Glutaraldehyde, Ammonia, Chloride, pH, ethanol/methanol.

Hiflow – 8260, 8015 GRO/DRO/MRO

In addition we will include RCRA 8 metals.

Like I said, we will be pulling these samples today or tomorrow, and will be ready to run analysis for all of the above listed constituents unless we hear otherwise from you.

“if the constituent is not identified in Items (i) or (ii) of Subparagraph (e) of Paragraph (5) of Subsection A of [19.15.29.11](#) NMAC, **the division shall consult with the responsible party to determine appropriate remediation of the release.**

Therefore, in a subsequent correspondence please provide the NMOCD with a list of constituents found in the frack fluid spilled so that appropriate sampling and remediation efforts can be discussed.
