XTO is requesting a second extension to the current deadline of September 30, 2019 for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Goldenchild 6 State SWD #1 (2RP-5421). The release was discovered April 26, 2019. Initial site assessment began May 06, 2019. Pipeline operations at the site prevented further site assessment and remediation activity prompting the initial extension request. However, ongoing facility upgrades have slowed progress at the site. Remediation work at the site began again on August 8, 2019 and final delineation samples are being collected, tomorrow, September 27, 2019. To ensure enough time for laboratory analysis results to be received and reviewed, and to complete a remediation work plan or closure report, XTO is requesting a 30-day extension of the current deadline until October 30, 2019.
