XTO is requesting an extension of the 90 day deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Muy Wayno 18 Fed 103H (2RP-5410). The current deadline is July 17, 2019. The spill occurred April 18, 2019 during frac operations. Frac and flowback operations have continued since that time. To ensure the safety of all personnel, non-essential personnel are not permitted on site during the frac and flowback operations. This has prevented XTO from beginning remediation work. Regular updates of the operational activities have been provided to ensure that work begins as soon as the frac and flowback operations are complete. To provide enough time to fully assess the site and conduct remediation work, XTO requests an extension of the deadline until October 17, 2019.
