All,

XTO is requesting a second extension to the current deadline of October 17, 2019 for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Muy Wayno 18 Federal #103H (2RP-5410). The release was discovered April 18, 2019 during frac operations. The ongoing frac and flowback operations onsite has prevented further remediation work due to site restrictions for safety concerns. An initial extension request was approved on July 15, 2019. Regular site updates have been provided to ensure remediation work began as soon as possible. The latest operational update, received October 4, 2019, stated that flowback operations are being finalized and equipment is being removed. The site should be accessible to continue remediation work this week. To provide enough time to finalize site assessment, remediation work, and complete a remediation work plan or closure report, XTO requests an extension of the deadline until January 17, 2020.
