Per my voicemail this afternoon, we completed initial sampling of our Site Investigation to determine horizontal and vertical extent of the impact from a release of hydrocarbons as a mist from the facility. While we have completed horizontal delineation some of the interior surface soil samples showed concentrations above regulatory limits. As a result, we had a consultant attempt additional vertical delineation but met refusal with hand-augurs just below the surface. We scheduled an excavator in order to complete additional sampling below the surface and have completed that additional sampling and should have those results shortly. Because we are near the end of the initial 90 days, we
